ORDINANCE NO. 07-02-072

IMPOSING FEE FOR THE RENTAL OF STALL SITUATED AT THE MUNICIPAL FISH PORT AT SITIO KAW-AYAN, POBLACION, BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There shall be collected from occupants of stall situated at the Municipal Fish Port at Sitio Kaw-ayan, Poblacion, Bulalacao, Oriental Mindoro the rental fee of One Thousand Two Hundred Fifty Pesos (Php1,250.00) per month;

SEC. 2. The amount equivalent to three (3) months rental fee be likewise imposed upon the applicant for two (2) months advance and one (1) month deposit before the actual use of the stall;

SEC. 3. The fee for the rental of stalls at the Municipal Fish Port shall be paid to the Municipal Treasurer or his duly authorized representative on a monthly basis;

SEC. 4. The Lessee shall be allowed to occupy the stall for one (1) to three (3) years subject for renewal;

SEC. 5. The Lessee of a stall, who fails to pay the monthly rental fee within the prescribed period shall pay a surcharge of twenty five percent (25%) of the total rent due. Failure to pay the rental fee for three (3) consecutive months shall cause the automatic cancellation of the contract of lease of stall without prejudice to swing the lessee for the paying the unpaid rents. The stall shall be declared vacant and subject for rent.

SEC. 6. There shall be a Memorandum of Agreement between the Lessee and the Municipal Mayor stating therein policies and terms and conditions in the grant of rental rights, operation and management of the Municipal Fish Port and its premises;

SEC. 7. Any violation of this Ordinance shall be punished by a fine of not less than Five Hundred Pesos (Php500.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court;

SEC. 8. This ordinance shall take effect after ten days of posting.




