SPECIAL ORDINANCE AMENDING SPECIAL ORDINANCE NO. 10-07-75 BY CHANGING THE NAME OF DUEZON RAPAL INTO RAYMUNDO R. RAPAL

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Special Ordinance No. 10-07-75 is hereby amended by changing the name of Duezon Rapal into Raymundo R. Rapal to be read as follows:



SEC. 3. This Special Ordinance shall take effect immediately.


