SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MANAGER, ORMIN LAND LENDERS, INC., BONGABONG, ORIENTAL MINDORO TO SECURE SALARY LOAN FOR THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, THIS PROVINCE




