SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT TO ANY INTERESTED AND COMPETENT PERSON LEASING THE VACANT FACILITIES OF THE MUNICIPAL GOVERNMENT FOUND AT THE MUNICIPAL FISH LANDING PORT, POBLACION, BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1.
