SPECIAL ORDINANCE NO. 10-02-56

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) FOR GRANTING THE AMOUNT OF FIFTEEN MILLION PESOS (PHP15M) TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM SITIO PUTAT TO SITIO BISLIG TO SITIO BURBO TO SITIO BUNGA, ALL OF BARANGAY BALATASAN, THIS MUNICIPALITY AND RATIFYING THE SAME CONTRACT

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


SECTION 1. The Municipal Mayor, the Honorable Emilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Honorable Arthur C. Yap, Secretary, Department of Agriculture (DA) for granting the amount of Fifteen Million Pesos (Php15M) to the Municipality of Bulalacao, Oriental Mindoro to be used for the construction/rehabilitation of Farm to Market Road from Sitio Putat to Sitio Bislign to Sitio Burbo to Sitio Bunga, all of Barangay Balatasan; and to ratify the same contract;

SEC. 2. This Special Ordinance shall take effect immediately.




