SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) FOR THE IMPLEMENTATION OF VARIOUS PROJECTS UNDER THE GRASSROOTS PARTICIPATORY BUDGETTING (GPB) IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, the Honorable Edna C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Department of Trade and Industry (DTI) for the implementation of the following eligible projects under the Grassroots Participatory Budgetting (GPB) in the Municipality of Bulalacao, Province of Oriental Mindoro; to wit:

- ii. Integrated Development Program for Chili Processing;
- iii. Integrated Development and Promotion of Buri-Based Products;
