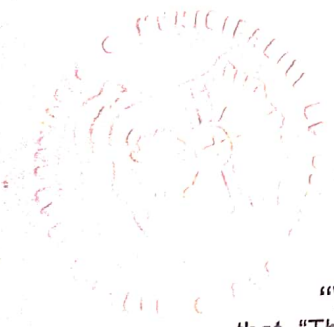

**"WHEREAS**, the 1987 Philippine Constitution, Article I, Section 9 states  
that, "The State shall promote a just and dynamic social order that will ensure  
the prosperity and independence of the nation and free the people from  
poverty through policies that provide adequate social services, promote full  
employment, a rising standard of living, and an improved quality of life for all";

**"WHEREAS**, on February 28, 2023 the oil tanker MT Princess Empress  
carrying 800,000 liters of industrial fuel oil sank off Naujan, Oriental Mindoro  
caused by engine trouble (overheating), based on the experts, more or less  
36,000 hectares of coral reefs, mangroves and sea grasses were possibly  
affected that led to prohibit fishing activities on contaminated coastal areas;




