WHEREAS, pursuant to item no. 2, Section 447 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan shall generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the municipality as provided for under Section 18 of this Code with particular attention to agro-industrial development and countryside growth and progress and relative thereto shall reclassify land within the jurisdiction of the municipality subject to pertinent provisions of this Code;

WHEREAS, Section 20 of the same Code states that a municipality through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of utilization or disposition;


