MUNICIPAL ORDINANCE NO. 22-08-327

AN ORDINANCE INSTITUTIONALIZING THE ANIMAL VACCINATION PROGRAM IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

WHEREAS, Section 3 of Batas Pambansa Blg. 97 or the Domestic Animal Disease Prevention and Control Act of 1980 states that the Ministry (Department) of Agriculture shall make compulsory the vaccination of susceptible animals and poultry should there be a threat or existence of a highly communicable animal or avian disease in a certain locality. Such susceptible species of animals shall be vaccinated as frequently as deemed necessary by the Director of the Bureau of Animal Industry;

WHEREAS, Section 4 of Republic Act No. 9482 or the Anti-Rabies Act of 2007 mandates that there shall be a National Rabies Prevention and Control Program to be implemented by a multi-agency/multi-sectoral committees chaired by the Bureau of Animal Industry of the Department of Agriculture. The program shall be a multi-agency effort in controlling and eliminating rabies in the country;

WHEREAS, Republic Act No. 8485 or the Animal Welfare Act of 1989 mandates the protection and promotion of the welfare of all animals in the Philippines by supervising and regulating the establishment and operation of all facilities utilized for breeding, maintaining, keeping, treating or training of all animals either as objects of trade or as household pets;

WHEREAS, in the observance of the mandates of Republic Act No. 7160 or the Local Government Code of 1991, the Local Government Unit of Bulalacao shall ensure the efficient and effective delivery of basic services specifically in taking measures and adopting quarantine regulations to prevent the introduction and spread of diseases within its territorial jurisdiction and in order to promote its general welfare;

WHEREAS, by virtue of this Ordinance, medical problems caused by rabies due to animal bites will be resolved; prohibit stray, unwanted and unvaccinated dogs from roaming around public places, and protect the Bulalacaonons from the danger of rabies, thus, responsible pet ownership is established;

NOW, THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

Section 1. Statement of Policy. It is the policy of the Local Government Unit of Bulalacao (LGU of Bulalacao) to ensure that all Bulalacaonons are being protected from any diseases that can be acquired by any of animal bites such as rabies, and at the same time ensuring the wellness, protection and safety of the animals in homes or as part of the businesses as it is mandated in Batas Pambansa Blg. 97 and Republic Act No. 8485.

Section 2. Title. This Ordinance is entitled as stated and shall be also known as "2022 Animal Vaccination Ordinance of Bulalacao".

Section 3. Definition of Terms. As used in this ordinance, the following terms shall mean:

- a. **Animal** refers to any common domestic animals that can obtain rabies like dogs and cats.
- b. **Bitten** refers to an act by which a dog or cat seizes, cuts or grips with its teeth which caused the skin of a person to be wounded, lacerated, pierced or scratched.
- c. **Owner** refers to any person keeping, sheltering or having charge or control of, or permitting an animal to habitually be or remain on or be lodged or fed within such person's house or any other property, its yard or premises.

- d. **Rabies Transmission** refers to the transmission or passage of the Rabies Virus through a bite by an infected animal, or through contamination with virus-laden saliva on breaks in the skin and of mucous membranes such as the eyes, the lips, the mouth, or the genital organs.
- e. **Rabies Vaccination of Human** refers to the inoculation of humans, with modern day rabies vaccine or Rabies Immunoglobulin, by a trained doctor or nurse under the supervision of a medical practitioner.
- f. **Rabies Vaccination of Animals** refers to the inoculation of a dog or a cat with a Rabies vaccine by a licensed government or private veterinarian or trained individual under the direct supervision of a licensed veterinarian.

Section 4. Municipal Rabies Control and Consultative Committee (MRCCC). A functional Municipal Rabies Control and Consultative Committee (MRCCC) shall be organized and established to achieve its purpose and shall retain the main authority of ensuring the proper, effective and sustainable implementation of this rabies control ordinance as well as other rabies control-related programs and activities as it may deem necessary. The MRCCC shall submit plans and programs for inclusion in the Municipal Annual Budget.

The Committee shall be composed of the following members, subject to additional membership as the need occurs:

- a. Chairperson : Municipal Mayor
- b. Vice Chairperson : Chairperson, SB Committee on Health
Chairperson, SB Committee on Agriculture
- c. Members : Municipal Health Officer
Municipal Agriculturist
Municipal Veterinarian
Chief of Police
President, Liga ng mga Barangay
Non-Government Organizations Representative

Section 5. Functions. The MRCCC shall have the following functions:

1. Conduct and supervise animal immunization activities and animal control measures.
2. Ensure availability and adequate supply of animal anti-rabies vaccination and animal tags at all times for the target areas.
3. Impounding field control and disposition of stray, unwanted and unvaccinated animals in accordance to Municipal Ordinance No. 20-06-269 or The 2020 Stray Animal Prohibition Ordinance of Bulalacao.

4. Establish a central data system for registered and vaccinated animals.
5. Strengthen information, education and communication on rabies prevention and control.
6. Encourage the practice of responsible pet ownership.
7. Provide supply of human post-exposure treatment to animal bite victims and provisions of pre-exposure treatment to high-risk personnel.
8. Encourage the strict enforcement of Municipal Ordinances relevant to rabies control.
9. Establish and maintain a rabies-free zone Municipality.
10. Train identified Barangay vaccinators.

Section 6. Implementing Rules and Regulations. The Municipal Mayor in coordination with MHO and MAO shall issue implementing rules and regulations to ensure compliance of the Ordinance.

Section 7. Appropriation. The fund needed for the implementation of this ordinance shall be included in the Annual Budget of the Local Government Unit of Bulalacao.

Section 8. Repealing Clause. Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

Section 9. Separability Clause. If any provision of this Ordinance is declared invalid, the remaining provisions hereof not affected thereby shall remain in full force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.


Section 10. Effectivity. This Ordinance shall take effect after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.


