AN ORDINANCE GRANTING HONORARIUM TO DR. FLORECITA F. LINDO, M.D, MHA, PSYCHIATRIST IN THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00) MONTHLY FOR MEDICAL SERVICES RENDERED TO MENTALLY CHALLENGED INDIVIDUAL PATIENTS OF BULALACAO, ORIENTAL MINDORO

WHEREAS, at present, Bulalacao needs a Psychiatrist who will examine thirty-eight (38) mentally challenged individuals of our Municipality who needed maintenance medicine and consultation.

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. A monthly honorarium in the amount of ten thousand pesos (PhP10, 000 00) monthly is hereby granted to Dr. Florecita F. Lindo, M D., MHA for her medical services to mentally challenged individuals of Bulalacao upon submission of the following documents:

- a. Letter of Intent
- b. Accomplishment reports every end of the month

SECTION 2. She will be entitled only for the honorarium only and if she rendered her medical services within the month.

SECTION 3. The medical service of Dr. Florecita F. Lindo is not only limited to identified 38 mental patients of Bulalacao, Oriental Mindoro but to any individual residing within the municipality who are experiencing other mental disorder or illness such as depression, anxiety disorders, schizophrenia, eating disorders and addictive behaviors.

SECTION 4. Disbursement of funds is subject to the usual accounting and auditing rules and regulations. The fund needed for the implementation of this ordinance shall be included in the Professional Fees under the Office of the Municipal Mayor.

SECTION 5. This Ordinance shall take effect upon approval.


