RESOLUTION IN THE MATTER OF REQUESTING THE DISTRICT ENGINEER OF PUBLIC  
WORKS, CALAPAN, ORIENTAL MINDORO, THAT THE CONSTRUCTION OF PUBLIC MARKET  
IN BULALACAO, ORIENTAL MINDORO AS PER SPECIFICATION PLAN BE UNDERTAKEN  
THROUGH NEGOTIATED CONTRACT IN THE AMOUNT OF P4,500.00 SUPERVISE BY SAID  
ENGINEER:

KNOWINGLY, that the construction of Public Market in the municipality  
of Bulalacao, there is an amount of P4,500.00 available, except the con-  
struction for flooring which needs fund to be appropriated for the com-  
pletion of it;

REALIZING, that some materials to be used for the construction of  
Public Market according to the specification plan, be furnished and taken  
within this municipality (local materials) excluding some materials to  
be used such as nails, corrugated and plain roofing to be used and etc.,

CONSIDERING, that the amount is not sufficient for the completion  
of said public market, the municipal Treasurer of this municipality is  
empowered and authorized by this body, the municipal council to find  
ways and means to appropriate from any fund and/or other revenues income  
which is available to sustain the construction until fully completed  
in accordance with the specification plan of said public market; and

on motion of Vice-Mayor Dolores S. Lago and duly seconded by Coun-  
cilor Ulfrano C. Rindino be it,

NOW, THEREFORE, resolved that the construction of Public Market in  
Bulalacao, Oriental Mindoro be undertaken through negotiated contract  
which is duly supervise by the District Engineer of the Bureau of Public  
Works according to the specification plan for the construction.
