RESOLVED, to approve the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 9  
 SUPPLEMENTAL BUDGET NO. 9  
 FOR CALENDAR YEAR 1981

APPROPRIATING THE AMOUNT OF ₱12576.85 FOR THE SALARY DEFICIENCY OF TWO HIGH SCHOOL TEACHERS OF BULALACAO MUNICIPAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO TO BE TAKEN FROM THE UNAPPROPRIATED BALANCE OR OUT OF ANY APPROPRIATED AMOUNT OR TO REVERT ANY FUND ALREADY APPROPRIATED BUT NEVERTHELESS NOT YET UTILIZED FOR THE PURPOSES.

Section I.- There is hereby Appropriated the sum of ₱12576.85, to be taken from the unappropriated balance or out of any appropriated amount or to revert any fund already appropriated but nevertheless not yet utilized for the purpose, for the Salary deficiency of two High School teachers of Bulalacao Municipal High School, Bulalacao, Oriental Mindoro, described as follows, to wit:

- a) Salary of deficiency of two High School teachers which is not included in the National Plantilla and eligible for the 65% National Aid of total basic Salary of ₱603.00. (₱211.05 to ₱603.00 per month) ----- ₱9,406.80

Section 2.- This Ordinance shall take effect immediately.




