RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 6 ✓

ORDINANCE NO.

DECLARING EVERY SATURDAY OF THE MONTH AS THE MARKET DAY OF BULALACAO, ORIENTAL MINDORO AND SHALL PROVIDE FINES AND PUNISHMENT FOR EVERY VIOLATION HEREOF

WHEREAS, the town of Bulalacao, Oriental Mindoro has no Market day;

WHEREAS, Market day in this town is vital and necessary in order that people can sell their by-products regularly;

WHEREAS, in order to have a regular market day in this town, the Sangguniang Bayan, hereby Ordains, that:

SECTION 1.- Be it known that every Saturday of the month is declared as Market day of the town of Bulalacao, Oriental Mindoro;

SECTION 2.- All persons having dried and fresh fish, pigs cows, carabaos, chickens, and other commercial products not mentioned hereof are hereby required to sell the above in the Market every Saturday of the month;

SECTION 3.- Persons, corporations, associations and companies are strictly prohibited to sell or buy the products mentioned above, outside the Market place during Saturdays of every month;

SECTION 4. Violation of this Ordinance or parts hereof, shall be fined the amount of ₱50.00 to ₱200.00 or an imprisonment of 10 to 30 days or both such fine or imprisonment at the discretion of the court;

SECTION 5.- Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 6.- This Ordinance shall take effect immediately after its passage;

UNANIMOUSLY APPROVED.

There having no other business to be transacted so motion of Hon. Amparo S. Gregorio, seconded by Hon. Manuel G. Merlin, the Session was adjourned at 12:00 O'clock in the morning.
