RESOLUTION REQUESTING THE ADMINISTRATOR OF THE NATIONAL ELECTRIFICATION ADMINISTRATION, QUEZON CITY, TO INTERVENE AND FACILITATE THE COMPLETION OF ELECTRIFICATION OF BULALACAO, ORIENTAL MINDORO

WHEREAS, electrification was scheduled to be installed in this municipality since 1981;

WHEREAS, all the municipalities in the province of Oriental Mindoro have already enjoyed the benefit of electricity except the municipality of Bulalacao;

WHEREAS, the municipality of Bulalacao is included in the Electrification Program of the National Electrification Administration and also included in the loan granted to the Oriental Mindoro Electric Cooperative II (ORMECO II) which according to the plan will energize all municipalities from Socoro to Bulalacao;

WHEREAS, this body noticed that the installation of electrification project of this municipality was stopped due to unknown reason inspite that we believe that there is enough funds for this project; that it is included in the feasibility study and the loan granted to ORMECO II;

NOW, THEREFORE, resolved as it is hereby resolved, to request the NEA Administrator to intervene and facilitate the completion of electrification project in the municipality of Bulalacao for the interest and welfare of our constituents;

RESOLVED, FURTHER, that copies of this resolution be furnished the NEA Administrator, Quezon City and the Minister of Ministry of Human Settlements, Metro Manila, Thru: the Human Settlements Officer, Bulalacao, Oriental Mindoro for consideration...
