ORDINANCE NO

AMENDING RESOLUTION NO. 42, ORDINANCE NO. 4, SERIES OF 1982, BY INCREASING THE TUITION FEES IN THE BULALACAO MUNICIPAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO FROM ₱15.00 TO ₱17.00 FOR FIRST YEAR AND SECOND YEAR AND FROM ₱16.00 TO ₱18.00 MONTHLY FOR THIRD YEAR AND FOURTH YEAR, RESPECTIVELY

WHEREAS, the tuition fees in the Bulalacao Municipal High School is the lowest rate as compared to other Municipalities;

WHEREAS, this tuition fees need to be increased in order to meet the demand of the teachers and the school;

WHEREAS, in order to regulate the rate of tuition fees in the Bulalacao Municipal High School, the Sangguniang Bayan hereby ordains, that:

SECTION I.- All First year and second year students in the Bulalacao Municipal High School, Bulalacao, Oriental Mindoro are hereby required to pay a monthly tuition fees of ₱17.00 and ₱18.00 for third year and fourth year, respectively for the school year 1983-1984;

SECTION 2.- Previous Ordinance or Ordinances inconsistent with the Provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 3.- This Ordinance shall take effect immediately after its passage;
