EARNESTLY REQUESTING DR. BENJAMIN C. CRUZ, DIVISION SUPERINTENDENT, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF THREE (3) CLASSROOM BUILDING FOR THE PROPOSED MAUJAO NATIONAL HIGH SCHOOL LOCATED AT BARANGAY MAUJAO, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the 1987 Constitution provides that the State shall protect and promote the rights of all citizens to quality education and shall take appropriate steps to make such education accessible to all; It further mandated the establishment and maintenance of a system of free public education in the elementary and high school levels;

"WHEREAS, in response to the above-cited constitutional mandate, the Honorable Jesus M. Punzalan had filed House Bill No. 9594 entitled "Establishing a High School in Barangay Maujao, Municipality of Bulalacao, Province of Oriental Mindoro to be known as the Maujao National High School and appropriating funds therefor";

"WHEREAS, it is always believed that educating our people, especially the youth is one of the definite means of empowering them, enabling to actualize themselves through it, they would be placed in a better position to win their future;

"WHEREAS, once realized, the proposed high school would definitely redound to the socio-economic benefits of the people living therein and its adjacent barangays; Now, therefore, be it


