RESOLUTION NO. 97-11-150-A

AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY QUALIFIED PERSONS IN THE GRANT OF THE EXCLUSIVE RIGHT TO ESTABLISH, OPERATE AND MAINTAIN A COCKPIT IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, in accordance with Section 447 of Republic Act Numbered 7160, otherwise known as the Local Government Code of 1991, the sangguniang bayan is empowered to grant license or franchise to establish, operate and maintain cockpit within its jurisdiction;

"WHEREAS, the grant of such license/franchise provides an opportunity for the local government units (IGU's) to generate local funds which shall be of help in the delivery of basic services to the people;

"WHEREAS, the same law further provides that the local chief executive has the power to enter into agreements or contracts in behalf of the local government unit only upon authorization by the sanggunian concerned;

"WHEREAS, in order to facilitate the grant of such license/franchise, this Sanggunian gives the authority to the Municipal Mayor to exercise the right to any qualified person the exclusive right to establish, operate and maintain a cockpit in this Municipality; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Mayor, Gemma G. Salas, to enter into a negotiated contract with any qualified persons in the grant of the exclusive right to establish, operate and maintain a cockpit in the Municipality of Bulalacao, Province of Oriental Min-

doro.
