- i. San Roque to Bancal to San Juan
Barangay Road - 2.5 km. P 3M
- ii. San Roque to Libtong - 5.5 km. P 8.25 M
- iii. San Roque to Dangkalan - 4.5 km. P 6.75 M
- iv. SAMABA to Bancal to Ambulong - 4.5 km. P 6.75 M


