RESOLUTION NO. 97-11-144

AUTHORIZING THE PRE-QUALIFICATION, BIDS AND AWARDS COMMITTEE (PBAC) TO ACQUIRE GOOD LUMBER FOR THE REHABILITATION OF BAROMBONG BRIDGE, BARANGAY NASUCOB, THIS MUNICIPALITY THROUGH "TAKAY SYSTEM" WITH A RATE OF EIGHTEEN PESOS (P18.00) PER BOARD FEET IN VIEW OF THE TWO CONSECUTIVE FAILED BIDDINGS THEREOF

"WHEREAS, Barombong Bridge is very vital in the transport of agricultural produce coming out from Imbuyungan, Barangay Nasucob and the nearby sitios;

"WHEREAS, such bridge annually needs repair and rehabilitation to make it serviceable to the people;

"WHEREAS, funds for such repair and rehabilitation of the said bridge were duly allocated by the government in order to alleviate the economic situation of those living therein;

"WHEREAS, according to the plan, the materials to be used thereof, some of which would be woods; the acquisition for them would be made through public bidding; However, two (2) of such failed for lack of the necessary number of participants; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Pre-qualification, Bids and Awards Committee (PBAC) to acquire good lumber for the rehabilitation of Barombong Bridge, Barangay Nasucob, this Municipality through Takay System with a rate of Eighteen Pesos (P18.00) per board feet in view of the two consecutive failed biddings thereof;
