EARNESTLY REQUESTING DR. ARISTEO BALDOS, PROVINCIAL HEALTH OFFICER, CALAPAN CITY TO INCLUDE BARANGAY SAN ISIDRO, BULALACAO, ORIENTAL MINDORO IN THE BOTIKA NG BARANGAY HEALTH PROGRAM AND TO GRANT SUFFICIENT SUPPLY OF MEDICINES FOR THE INDIGENT RESIDENTS OF THAT BARANGAY

"WHEREAS, Section 15, Article II of the 1986 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

"WHEREAS, it is learned that Botika ng Barangay was established under the flagship of the Social Reform Agenda with the main objective of arresting various health problems in the remote areas through the availability of medicines intended for its immediate relief;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is grateful for being one of the recipients of the Botika ng Barangay Program initiated and implemented by the Provincial Health Office which greatly improve health conditions in the far-flung Barangays of Maasin, Balatasan and Maujao;


