RESOLUTION NO. 97-08-125

RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE MUNICIPALITY OF BULALACAO, REPRESENTED BY MAYOR GEMMA G. SALAS, AND ENGINEER MELITON F. ACOSTA, SR., ENGAGING THE LATTERS SERVICES IN THE SURVEYING OF RESIDENTIAL LOTS BELONGING TO THE FORMER AND SITUATED AT BARANGAY CAMBUNANG, DATED AUGUST 22, 1997

"WHEREAS, this Sanggunian had authorized the Mayor Gemma G. Salas to enter into agreement with Engr. Meliton F. Acosta to survey the residential lots owned by the Municipal Government and situated at Barangay Cambunang, under Resolution No. 97-07-117;

"WHEREAS, Engr. Acosta caused the surveying of One Hundred Fourteen (114) lots in the noted area at Seven Hundred Pesos (P700.00) per lot with a total obligation of Seventy Nine Thousand Eight Hundred Pesos (P79,800.00);

"WHEREAS, it was agreed by the two parties that the Government shall extend Engr. Acosta with an intial payment of Forty Thousand Pesos (P40,000.00); Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Ratify the contract entered into by and between the Municipality of Bulalacao, represented by Mayor Gemma G. Salas, and Engr. Meliton F. Acosta, Sr., engaging the latters services in the surveying of residential lots belonging to the former and situated at Barangay Cambunang, dated August 22, 1997;
