REQUESTING THE MUNICIPAL MAYOR TO TAKE ADVANTAGE OF THE SUMMER SEASON FOR THE CONSTRUCTION OF FARM TO MARKET ROADS FUNDED UNDER THE 20% DEVELOPMENT FUND, CY-2001 TEMPORARILY UTILIZING THE ₱3M SURPLUS AND REVERT THE SAME AMOUNT ONCE THE CY-2001 MUNICIPAL ANNUAL BUDGET IS APPROVED

"WHEREAS, it is glad to note that the CY-2001 Annual Budget prioritized funding for the construction of several farm to market roads;

"WHEREAS, this Sanggunian believes that it is just proper and timely to take advantage of the summer season for the construction of farm to market roads funded under the 20% Development Fund, CY-2001 temporarily using and revert the same amount once the CY-2001 Annual Budget is approved;


"WHEREAS, the approval of the Annual Budget sometime in April seems to be of shortage of time for the implementation of infrastructural projects particularly farm to market roads because of the rainy season which starts in May or June;


"WHEREAS, it is understood that the construction of farm to market road hastens the socio-economic development of the community and its people; Now, therefore, be it


