EARNESTLY REQUESTING THE HONORABLE ALFONSO V. UMALI, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO ALLOCATE TWO THOUSAND (2,000) BAGS OF CEMENT TO BE USED FOR THE COMPLETION OF ACCESS ROAD TO THE MUNICIPAL FISH PORT OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is in dire need of an infrastructure support to handle fish catch in order to maximize the harvest from its marine resources;

“WHEREAS, In order to reduce post harvest losses, improve the quality of produce for domestic and export consumers, enhance monetary returns of small-scale fishermen and to promote efficient packing and processing, a fishing port needs to be constructed;

“WHEREAS, the fish port is approximately one (1) kilometer from the town proper that an access road is needed to facilitate the shipment of marine produce from the fishing port to any point of destination;

“WHEREAS, due to limited funds the access road is only half way of construction that its completion is believed to be realized through the assistance of Congressman Umali; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED; To: Earnestly request the Honorable Alfonso V. Umali, Congressman, 2nd District, Oriental Mindoro to allocate Two Thousand (2,000) bags of cement to be used for the completion of access road to the Municipal Fish Port of the Municipality of Bulalacao, Province of Oriental Mindoro;


