EARNESTLY REQUESTING HONORABLE RAMON REVILLA, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONCRETING OF BULALACAO-MAGSAYSAY NATIONAL HIGHWAY, A CIRCUMFERENTIAL ROAD CONNECTING THE PROVINCES OF ORIENTAL AND OCCIDENTAL MINDORO

“WHEREAS, it is happy to see that passenger jeepneys and other kinds of vehicles are traversing along the Bulalacao-Magsaysay National Highway, a circumferential road connecting the Provinces of Oriental and Occidental Mindoro for it facilitate the movement of people and shipment of goods;


“WHEREAS, seeing the socio-economic benefits that would derived from the functional circumferential road, it is very important, if the same road be made passable even during the rainy season;
