" RESOLUTION NO. 00-03-035

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2000 OF BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF THREE HUNDRED NINETY SIX THOUSAND ONE HUNDRED SIX PESOS AND SIXTY FIVE CENTAVOS (P396,106.65) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1, DATED FEBRUARY 12, 2000

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Bagong Sikat, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2000 showing therein the sources of income and barangay expenditures starting from January 1, 2000 up to December 31, 2000;

"WHEREAS, the Barangay Fund Annual Budget for FY 2000 of Barangay Bagong Sikat was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on March 6, 2000 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;


