"WHEREAS, Title I, Article I, Section 25 (b) of the Local Government

implementation functions shall coordinate with one another and with the local  
government units concerned in the discharge of these functions, they shall  
ensure the participation of local government units both in the planning and  
implementation of said national projects;

"WHEREAS, Title II, Chapter III, Article I, Section 444 (b.1.xvi) of the same law states that the Municipal Mayor shall call upon any national official or employee stationed in or assigned to the municipality to advise him on matters affecting the municipality and to make recommendations thereon, or to coordinate in the formulation and implementation of plans, programs and projects, and when appropriate, initiate an administrative or judicial action against a national government official or employee who may have committed an offense in the performance of his official duties while stationed in or assigned to the local government unit concerned;

"WHEREAS the Sangguniang Bayan of Bulalacao, Oriental Mindoro has existing ordinances that enforce to submit program of works and conduct pre-implementation and exit conferences on every program, project or activity implemented within its municipality, these are stated as follows:

- Municipal Ordinance No. 12-07-128 entitled "An Ordinance prescribing inspection report as requisite in the payment of all government infrastructure projects being undertaken and implemented in the Municipality of Bulalacao, Oriental Mindoro, creating for the purpose the municipal inspectorate team for infrastructure projects and prescribing penalties in case of violation thereof" was approved on July 26, 2012,
- Special Ordinance No. 16-03-11 entitled "Special Ordinance requiring all heads of national, regional, provincial government and other concerned agencies including contractors implementing infrastructure projects, programs and activities in every barangay comprising the Municipality of Bulalacao, Province of Oriental Mindoro to inform and submit program of works before the start of the project and to submit program of works before the start of the project and to require further the inspectorate team as signatories in the Certificate of Completion and Certificate of Acceptance for every project completed" was approved on March 17, 2016,
- Municipal Ordinance No. 16-09-167 entitled "An Ordinance requiring all officers and key employees of the Local Government Unit of Bulalacao, Oriental Mindoro to conduct pre-implementation and exit conferences on every program, project or activity implemented by the Local Government Unit of Bulalacao, Oriental Mindoro or in coordination or partnership with different national government agencies and local government units and even with private entities" was approved on September 30, 2016;

"WHEREAS, on July 25, 2024, the Municipal Mayor of Bulalacao issued the Executive No. 07-18 s. 2024 implementing the provisions of the Local Government Code on intergovernmental relations among the national government agencies and the local government units;

"WHEREAS, it has been escalated that some projects and programs from higher agencies implemented in Bulalacao did not comply the provisions of the abovementioned municipal ordinances;


"WHEREAS, this Sanggunian is humbly asking the higher agencies to execute thoroughly the abovementioned municipal ordinances to maintain its harmonious and respectful relationship to the local government unit which would provide effective and efficient implementation of projects, programs and activities that will be beneficial to the municipality as a whole; Now, therefore, be it...
