REITERATING THE REQUEST TO THE PHILIPPINE HEALTH INSURANCE CORPORATION, REGIONAL HEALTH INSURANCE OFFICE, REGION IV-B TO ACCREDIT THE BULALACAO COMMUNITY HOSPITAL AT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AS PHILHEALTH HOSPITAL

"WHEREAS, Article XIII, Section II of the 1987 Constitution declares that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. Priority for the needs of the underprivileged, sick, elderly, disabled, women and children shall be recognized. Likewise, it shall be the policy of the State to provide free medical care to paupers;


"WHEREAS, in conformity with the above objective, the Local Government Unit of Bulalacao, Oriental Mindoro appropriated the necessary funds for the payment of Philhealth premiums of its poor constituents mostly composed of elderly and Mangyans in order to provide them with at least a basic minimum package of health insurance benefits;


"WHEREAS, it is understood that there are various accreditation requirements that need to be complied with however, it will be much appreciated if the Philhealth Regional Office would guide the Bulalacao Community Hospital for its immediate accreditation; Now, therefore, be it
