"WHEREAS, it is sadly observed that high cost of medicines added to expensive health services brought heavy sufferings to our less fortunate mothers and sisters who could hardly cope-up with their daily basic needs to arrive that health disorder is left to be set aside until it becomes serious and incurable,


"WHEREAS, in order to lessen the burden of poverty already felt by these people, there is a need to give them a consolation by giving free medicines and conducting medical mission particularly now that various malignant diseases appear to attack. Now, therefore, be it
