"WHEREAS, for efficient and effective economical governance and for the general welfare of the Municipality and its inhabitants pursuant to Section 16 of Republic Act No. 7160, the local chief executive under Section 444 par. B (v) shall upon authorization by the Sangguniang Bayan represent the Municipality in all business transactions and signed on its behalf all bonds, contracts and obligations and such other documents made pursuant to law or ordinance;

"WHEREAS, our nation is an agricultural country and considering that we are still half-way towards the modernization of our agricultural technology were still majority of those engaged are classified to be marginal farmers who rely mostly to the services of carabaos in tilling the soil;
