BONGNGAT, MPA TO CONDUCT AN INVESTIGATION OF SPONSORED FACEBOOK PAGE IN THE NAME OF BULALACAO NGAYON FOR BEING MALICIOUS, DE FAMOTORY AND VIOLATION OF THE REPUBLIC ACT NO. 10175 OTHERWISE KNOWN AS ANTI-CYBERCRIME LAW

"WHEREAS, Section 2 of Republic Act No. 10175 also known as the Anti-Cybercrime Law provides that "the State recognizes the vital role of information and communications industries such as content production, telecommunications, broadcasting electronic commerce, and data processing, in the nation's overall social and economic development. The State also recognizes the importance of providing an environment conducive to the development, acceleration, and rational application and exploitation of information and communications technology (ICT) to attain free, easy, and intelligible access to exchange and/or delivery of information; and the need to protect and safeguard the integrity of computer, computer and communications systems, networks, and databases, and the confidentiality, integrity, and availability of information and data stored therein, from all forms of misuse, abuse, and illegal access by making punishable under the law such conduct or conducts."

"WHEREAS, fake news is roughly defined as a made-up story with an intention to deceive, often geared toward getting clicks and it has become an issue because of an increasing number of it that meant to promote or advance a political opinion, or personality;
