ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO ALLOCATE THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM BARANGAY CAMPAASAN TO SITIO KAW-AYAN, BARANGAY POBLACION, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO



 Now therefore, be it


