ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO ALLOCATE THE AMOUNT OF FIVE MILLION PESOS (PHP5M) TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM SITIO BAGACAY, BARANGAY NASUCOB TO SITIO SINARAYAN, BARANGAY SAN JUAN, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 1, Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the Nation for the benefit of the people and an expanding productivity the key to raising the quality of life for all, especially the underprivileged;
