### RESOLUTION NO. 09-09-114

RESOLUTION REQUESTING HONORABLE RAMON "BONG" REVILLA, JR.,  
SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUND FOR  
THE CONCRETING OF FOUR (4) KILOMETER FARM TO MARKET ROAD  
FROM THE CONCRETE ROAD TO SITIO F.F. CRUZ, NAPISIAN, BARANGAY  
CAMBUNANG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, it is a sad commentary that the absence of concrete roads –  
barangay roads at Bulalacao, Oriental Mindoro explains why it continues to be  
poor as those living in the upland barangays hardly get their share in the basic  
services provided by government and are usually excluded from economic  
growth happening in the lowland areas;

"WHEREAS, progress in the upland barangays such as Cambunang will  
come by providing the necessary infrastructure, foremost of which are farm to  
market roads as they shall increase agricultural productivity, by allowing the  
inhabitants easy access to sources of productive inputs like fertilizers and high  
yielding seed varieties, likewise they shall reduce the transport cost and the time  
consumed in transacting business in government and private agencies;

"WHEREAS, it is maintained that the concreting of the four (4) kilometer  
farm to market road from the concrete main road to F. F. Cruz, Napisian,  
Barangay Cambunang shall help increase greater and faster economic  
movement in the area thus helping reduce poverty incidence in the area; Now,  
therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Honorable Ramon "Bong" Revilla, Jr., Senator, Republic of the Philippines to allocate fund for the four (4) kilometer farm to market road from the concrete road to Sitio F.F. Cruz, Napisian, Barangay Cambunang, Bulalacao, Oriental Mindoro.


