RELAMPAGOS, UNDERSECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT TO GRANT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH MEDICINES FOR THE INDIGENT RESIDENTS AMOUNTING TO THREE MILLION FIVE HUNDRED THOUSAND PESOS (PHP3.5M)**
