**EARNESTLY REQUESTING THE NATIONAL HOUSING AUTHORITY (NHA) TO GIVE PRIORITY TO THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE IMPLEMENTATION OF THE LOCAL HOUSING PROGRAM**

**"WHEREAS**, it is a declared policy of the State to provide the people with adequate and decent housing facilities through affordable financing package and to encourage various stakeholders to participate in the government housing program ;

**"WHEREAS**, pursuant to Section 4e of Republic Act No. 7835, the National Housing Authority is mandated to implement the Local Housing Program to make it more responsive to the constituents of the Congressional Districts;

**"WHEREAS**, the Local Housing Program is designated to ensure the equitable distribution of housing benefits nationwide and shall cover selected urban and urbanized areas in all congressional districts. The program is a joint undertaking between the participating LGU and NHA and other government agencies and private sector proponents;

**"WHEREAS**, the beneficiaries of this program include to low-income families belonging to the lowest 50<sup>th</sup> income percentile, particularly low-income earners from both government and private sectors;


