**RESOLUTION DECLARING THE RESOLUTION NO. 2020-10-06, SANGGUNIANG KABATAAN ANNUAL BUDGET FOR FY 2021 OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE SUM OF TWO-HUNDRED FOURTEEN THOUSAND SIX HUNDRED FORTY-ONE PESOS AND TEN CENTAVOS (PHP214,641.10) OPERATIVE IN ITS ENTIRETY**

“WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, Section 329 of the same law states that ten percent (10%) of the general fund of the barangay be set aside for the Sangguniang Kabataan and use of such fund shall be in accordance with the Annual Barangay Youth Investment Program and in compliance with the provisions of RA 10742 or the the SK Reform Act of 2015;

“WHEREAS, the Sangguniang Kabataan of Barangay Maasin, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2021 showing therein the sources of income and object of expenditures to this Sanggunian for review on September 9, 2021 pursuant to the provisions of Republic Act (R.A.) No. 7160 which is best shown below; to wit: Source: 10% SK Fund- PhP214,641.10
