RESOLUTION NO. 21-10-297

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 02 SERIES 2021, SUPPLEMENTAL BUDGET NO. 2 FOR FY 2021 OF BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF THIRTY-FOUR THOUSAND FIVE HUNDRED EIGHTY-FIVE PESOS AND SIXTY CENTAVOS (PHP34,585.60) OPERATIVE IN ITS ENTIRETY

“WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of Bagong Sikat, Bulalacao, Oriental Mindoro submitted its Supplemental Budget No. 2 for FY 2021 showing therein the sources of income and object of expenditures to this Sanggunian for review on September 8, 2021 pursuant to the provisions of Republic Act (R.A.) No. 7160 which is best shown below; to wit:
