### **RESOLUTION NO. 21-05-170**

**RESOLUTION ENDORSING TO THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)- MIMAROPA REGIONAL OFFICE THRU ORIENTAL MINDORO FIELD OFFICE THE PROPOSAL OF BULALACAO TAILORS ASSOCIATION (BTA) FROM THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 34 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government unit shall promote the operation and establishment of people's nongovernmental organizations to become active partners in the pursuit of local autonomy;

**"WHEREAS**, Section 35 of the same law further provides that local government units may enter into a joint ventures and such other cooperative arrangements with people's nongovernmental organization to engage in the delivery of certain basic services, capability building and livelihood projects and to develop local enterprise designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance and enhance economic and social well-being of the people;

**"WHEREAS**, the Department of Labor and Employment is one of the executive departments of the Philippine government mandated to formulate policies, implement programs and services, and serve as the policy-coordinating arm of the Executive Branch in the field of labor and employment, it is tasked with the enforcement of the provisions of the Labor Code;

**WHEREAS**, the Local Government of Bulalacao is focus and constant in providing livelihood and work opportunities and in improving the economic status of the municipality as a whole by doing certain projects and services that are beneficial to its people;

**WHEREAS**, the Bulalacao Tailors Association (BTA) is a Sangguniang Panlalawigan- accredited association that was registered on February 8, 2018 with DOLE Registration No. ORMIN 2018-0030, it has 33 members who are all women residing at Bulalacao;

**"WHEREAS**, this Sanggunian fully supports the goal of the BTA to provide additional livelihood opportunities and financial income to its members and even non-members, to introduce its garment industry to the whole province, and to have a Bulalacao-based store that can sell its own clothing and other related products;




