RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 1, CY 2017 OF BARANGAY POBLACION AMOUNTING TO NINETEEN THOUSAND THREE HUNDRED ONE PESOS AND TWO CENTAVOS (PhP19,301.02) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1-2017 DATED MAY 15, 2017

RESOLVED AS IT IS HEREBY RESOLVED To: Approve Supplemental Budget No. 1 CY 2017 of Barangay Poblacion amounting to Nineteen Thousand Three Hundred One Pesos and Two Centavos (PhP19,301.02) passed under Sangguniang Barangay Appropriation Ordinance No. 1-2017 dated May 15, 2017 with the following recommendations, to wit:

1. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
2. That, the disbursement of fund shall be in accordance with COA Rules and Regulations;
3. That, the Sangguniang Barangay of Poblacion is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;
4. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Poblacion in connection with the implementation of said appropriation ordinance.


