**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 07-2019 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO ENTITLED "REALIGNING THE AMOUNT OF TWENTY NINE THOUSAND ONE HUNDRED FORTY PESOS ONLY (PhP29,140.00) TAKEN FROM MAINTENANCE OF UTILITY WORKER, MAINTENANCE OF ROADS & BRIDGES, LEGAL SERVICES, GASOLINE & SUPPORT TO BARANGAY POLICE TO AUGMENT FUND FOR ELECTRICITY EXPENSES, MAINTENANCE OF BARANGAY HALL AND WATER EXPENSES UNDER MOOE" OPERATIVE IN ITS ENTIRETY**

**"WHEREAS**, Appropriation Ordinance No. 07-2019 of Barangay Poblacion, Bulalacao, Oriental Mindoro entitled "Realigning the amount of twenty nine thousand one hundred forty pesos (PhP29,140.00) taken from maintenance of utility worker, maintenance of roads & bridges, legal services, gasoline & support to barangay police to augment fund for electricity expenses, maintenance of barangay hall and water expenses under MOOE" was submitted to this Sanggunian for review on November 21, 2019 pursuant to the provisions of Republic Act (R.A.)
