**RESOLUTION APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO FOR CALENDAR YEAR 2020**

**"WHEREAS**, the Local Government Unit of Bulalacao, Oriental Mindoro adopted the 1<sup>st</sup> Tranche of the Modified Salary Schedule for Local Personnel pursuant to Republic Act No. 11466, otherwise known as the "Salary Standardization Law of 2019" and authorizes the grant of additional benefits;

**"WHEREAS**, R.A. 11466 also provides for grant of the Mid-Year Bonus as part of the incentives under the Total Compensation Framework (TCF). Likewise, it states that the Program on Awards and Incentives for Service Excellence (PRAISE) instituted by the Civil Service Commission (CSC) pursuant to the provisions of Executive Order No. 292 (Administrative Code of 1987) shall be categorized under the incentives component of the TCF;

**"WHEREAS**, pursuant to Section 6.0 of Local Budget Circular No. 121 dated, January 24, 2020, the implementation of the Modified Salary Schedule in the Local Government Units shall take effect not earlier on January 1, 2020;

**"WHEREAS**, the Municipal Development Council composed of punong barangays and various sectoral groups convened on June 16, 2020 where, thereafter forwarded to this Sanggunian for approval of MDC Resolution No. 05-2020 prioritizing the implementation of Republic Act No. 11466; **Now, therefore, be it**
