RESOLUTION NO. 21-02-070

RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO CONDUCT ASSESSMENT ON THE PROPOSED REHABILITATION, RECONSTRUCTION, OR REROUTING OF NATIONAL HIGHWAY (BAGONG SIKAT SECTION) AND CONSTRUCTION OF PROTECTION WALL IN PROVINCIAL ROAD (CAMBAYANG-CABUGAO SECTION) IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

“WHEREAS, the DPWH functions as the engineering and construction arm of the Government and is tasked to continuously develop its technology for the purpose of ensuring the safety of all infrastructure facilities and securing for all public works and highways the highest efficiency and quality in construction;

“WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of province of Oriental Mindoro, has a distinct geographical features with a population of 39, 107 based on 2015 census;

“WHEREAS, Bulalacao, on its way to being an agro-tourism destination in MIMAROPA Region, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

“WHEREAS, it is important to conduct assessment on certain sections of provincial and national roads prior to its rehabilitation, repair, or reconstruction to check whether the elevations in areas of terrain possess undesirable slopes or prone to landslide, liquefaction or the landscape needs to be shaped and engineered arduously;

"WHEREAS, the subject sections of said provincial and national roads pose hazard to the public as road portions and protection walls have been significantly damaged because of erosion and soil liquefaction;

"WHEREAS, immediate intervention from DPWH is most necessary to ensure public safety, prevention of further damages to infrastructure and properties, and uphold structural integrity of public facilities and utilities.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Department of Public Works and Highways (DPWH) to conduct assessment on the proposed rehabilitation, reconstruction, or rerouting of national highway (Bagong Sikat Section) and construction of protection wall in provincial road (Cambayang-Cabugao Section) in the Municipality of Bulalacao, Province of Oriental Mindoro.
