RESOLUTION NO. 20-06-296

EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO THRU GOVERNOR HUMERLITO A. DOLOR TO EXTEND NECESSARY INTERVENTION IN SEEKING REVERSAL OF THE EXECUTIVE ORDER ISSUED BY THE FORMER PRESIDENT GLORIA MACAPAGAL ARROYO EXEMPTING FROM COMPREHENSIVE AGRARIAN REFORM PROGRAM CERTAIN LOTS SITUATED IN BARANGAY SAN ROQUE, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the issue of land ownership in Barangay San Roque, Bulalacao, Oriental Mindoro brought depression, worries and deep emotional turmoil for both the residents and officials for life becomes so uneasy and uncomfortable and fear of losing their homes and investments may come at any time;

"WHEREAS, on May 6, 2009, former President Gloria Macapagal Arroyo thru a petition filed by Anzaldo Family in 2006 released an Executive Order with Finality exempting certain lots situated in Barangay San Roque from Comprehensive Agrarian Reform Program which lead to the suspension of the distribution of CLOA to hopeful beneficiaries;

"WHEREAS, residents of Barangay San Roque together with the Local Government Unit of Bulalacao, Oriental Mindoro joint efforts and make various legal means to ascertain their rights over the land that are homes to local folks for so many years;


"WHEREAS, the intervention of the Provincial Government thru Governor Bonz Dolor is direly needed to push this noble objective that shall benefit the poor and the vulnerable residents of Barangay San Roque; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Provincial Government of Oriental Mindoro thru Governor Humerlito A. Dolor to extend necessary intervention in seeking reversal of the Executive Order issued by the Former President Gloria Macapagal Arroyo exempting from Comprehensive Agrarian Reform Program certain lots situated in Barangay San Roque, Bulalacao, Oriental Mindoro;




