RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 04-2017 OF BARANGAY POBLACION REALIGNING THE AMOUNT OF NINETY TWO THOUSAND EIGHT HUNDRED FIFTY NINE PESOS AND EIGHT CENTAVOS (PHP92,859.08) TAKEN FROM PERSONAL SERVICES SAVINGS TO AUGMENT FUND FOR MID-YEAR AND YEAR-END BONUS
