RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03-2017 OF BARANGAY SAN FRANCISCO ENTITLED REALIGNING THE AMOUNT OF SEVENTY THOUSAND TWO HUNDRED TEN PESOS AND EIGHTY CENTAVOS (PHP70,210.80) TAKEN FROM IMPROVEMENT OF BARANGAY STREETLIGHT TO AUGMENT FUND FOR IMPROVEMENT OF WATER SYSTEM OF BARANGAY SAN FRANCISCO, BULALACAO, ORIENTAL MINDORO
