RESOLUTION REQUESTING THE PROVINCIAL LEGAL OFFICE THRU ATTY. KRISTINE GRACE L. SUAREZ, PROVINCIAL LEGAL OFFICER TO FAVORABLY CONSIDER THE PREPARATION OF PROTEST AGAINST THE TWO (2) FORESHORE LEASE APPLICATIONS AND SIX (6) CERTIFICATE OF MANGROVE STEWARDSHIPS RENEWAL APPLICATIONS IN SUGUICAY ISLAND FILED BY CERTAIN INDIVIDUALS IN COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) IN SAN MARIANO, ROXAS, ORIENTAL MINDORO

“WHEREAS, this Office is informed that there are two (2) Foreshore Lease Applications and six (6) Certificate of Mangrove Stewardships (CMS) filed on Suguicay Island in the Office of the Community Environment and Natural Resources (CENRO), San Mariano, Roxas, Oriental Mindoro by certain individuals;

“WHEREAS, the Foreshore Lease Applications filed on Suguicay Island under Foreshore Lease Application No. (IV-C-3) is in the name of Theofredo Sandico covering an area of 12,661 sq. meters and Foreshore Lease Application No. (IV-C-3) 103 in the name of Fernando Sandico covering an area of 11,899 sq. meters;

“WHEREAS, in addition to the above, there are six (6) Certificate of Mangrove Stewardships (CMS) filed on Suguicay Island namely:

- i. Teresita Magtoto, grantee of CMS No. 029864/0420052058 by virtue of Mangrove Stewardship Agreement dated May 17, 1993 with an area of 4.8 hectares;
- ii. Ida Corazon R. Sandico, grantee of CMS No. 029865/0420052057 by virtue of Mangrove Stewardship Agreement dated May 17, 1993 with an area of 4.0 hectares;

- iii. Dulce Sandico, grantee of CMS No. 029864/0420052058 by virtue of Mangrove Stewardship Agreement dated May 17, 1993 with an area of 4.8 hectares;
- iv. Mary Grace Sandico Ozaeta, grantee of CMS No. 065255/0420052060 by virtue of Mangrove Stewardship Agreement dated May 10, 1993 with an area of 4.64 hectares;
- v. Theofredo Sandico, grantee of CMS No. 065252/0420052061 by virtue of Mangrove Stewardship Agreement dated May 10, 1993 with an area of 5.0 hectares and;
- vi. Fernando H. Sandico, grantee of CMS No. 065251/0420052062 by virtue of Mangrove Stewardship Agreement dated May 17, 1993 with an area of 5.0 hectares;

"WHEREAS, all these Stewardships will expire on 2018 however, on May 17, 2017, they all submitted "Petition for Renewal of Mangrove Stewardship Agreement and Certification;

"WHEREAS, the Municipality of Bulalacao always takes its definite stand to protect its foreshore and salvage areas within its territorial jurisdiction and it should not be opened for lease or sale to any private or public individual or entities because these areas should be preserved for future agro-tourism improvements that shall redound to the social and economic benefits of both the community and its people; Now, therefore, be it

Suarez, Provincial Legal Officer to favorably consider the preparation of protest against the two (2) Foreshore Lease Applications and six (6) Certificate of Mangrove Stewardships renewal applications in Suguicay Island filed by certain individuals in Community Environment and Natural Resources Office (CENRO), San Mariano, Roxas, Oriental Mindoro;
