“WHEREAS, dancesports is the activity that combines sport and dance and that allows the participants to improve physical fitness and mental well-being to form social relationships and to obtain results in competition at all levels;

“WHEREAS, the art of dancing is important to education because the arts research shows that students who study dance are more self-motivated, disciplines and focused in their everyday lives, expressive in their communication of emotions, thoughts and feelings, able to critically analyze their own work and the work of others;

“WHEREAS, on account of the explanations mentioned above, the students and teachers of Bulalacao National High School, Bulalacao, Oriental Mindoro is strongly recommending that dancesports be again included in the conduct of sports activities in the Regional Sports Athletic Competition which was eliminated for several years for reasons not clearly stated to the dissappointments of students, parents and teachers alike;
