EARNESTLY REQUESTING THE DEPARTMENT OF HEALTH TO SUPPORT THE IMPLEMENTATION OF UNIVERSAL HEALTH CARE ACT AND EXPRESSING THANKS AND GRATITUDE FOR CHOOSING THE PROVINCE OF ORIENTAL MINDORO AS ONE OF ITS PILOT AREAS

"WHEREAS, Republic Act 11223 or the Universal Health Care Law will automatically enroll Filipino citizens into the National Health Insurance Program and expand Philhealth coverage to include free medical consultations and laboratory tests;

"WHEREAS, under the law, the Philippine Health Insurance Company (Philhealth) will have expanded coverage to include free consultation fees, laboratory tests and other diagnostic services. It also aims to improve doctor to patient ratio, upgrades hospital bed capacities and equipment and established more hospital in remote areas;

"WHEREAS, the Province of Oriental Mindoro wish to express thanks and gratitude to the Department of Health for implementing the Universal Health Care Law that shall benefit large volume of its constituents living below poverty who could hardly cope-up with their basic medical needs;

"WHEREAS, it is highly hoped that implementation of the Universal Health Care Law in the province would be more successful and realistic to achieve its noble objective of delivering a complete health package to the people;
