RESOLUTION REQUESTING A-TEACHER PARTYLIST THRU REPRESENTATIVE MA. VICTORIA V. UMALI TO FACILITATE THE INCLUSION OF UPGRADING THE CATEGORY OF DEPARTMENT OF EDUCATION, DIVISION OF ORIENTAL MINDORO FROM MEDIUM TO LARGE CATEGORY IN THE 2021 GENERAL APPROPRIATION ACT

WHEREAS, in accordance to Section 6 of Presidential Decree No. 1177, the budgets of national government agencies shall take into full and explicit consideration the goals, plans and requirements of their respective regional offices, in the interest of full government response to local thinking and initiative; the budget preparation process shall originate at regional and local levels and shall be consolidated and reviewed by the central office of the various national agencies, the regional development strategies and plans including physical framework and resource-use plans shall be considered in the preparation of the budget;

WHEREAS, pursuant to Republic Act No. 9155 otherwise known as the Governance of Basic Education Act of 2001, it provided a framework for the governance of education, decentralizing governance to the field, and making the schools and learning centers the heart of the education system, the law also established the authority and accountability of the various organization levels of the Department of Education (DepEd);

WHEREAS, the regional and schools division offices are categorized based on size classification where the Division of Oriental Mindoro and City of Calapan are in the same medium category however the former has more numbers of schools and bigger population of teachers and students which qualify it to the large category;

WHEREAS, to bring more effective services, the Division of Oriental Mindoro shall be upgraded from medium to large category that will also intend to have additional budget for maintenance and other operating expenses, capital outlay and personal services, **Now, therefore, be it;**

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the A-Teacher Partylist thru Representative Ma. Victoria V. Umali to facilitate the inclusion of upgrading the category of the Department of Education, Division of Oriental Mindoro from medium to large category in the 2021 General Appropriation Act.






