**RESOLUTION NO. 19-07-085**

**RESOLUTION EXPRESSING STRONG OBJECTION OF THE LOCAL GOVERNMENT UNIT OF BULALACAO AGAINST THE OPERATION OF PERYAHAN NG BAYAN BY THE GLOBALTECH MOBILE ONLINE CORPORATION, ALL TYPES OF ILLEGAL NUMBER GAMES AND ANY OTHER FORMS OF GAMBLING WITHIN THE JURISDICTION OF BULALACAO, ORIENTAL MINDORO**

**“WHEREAS**, gambling is a wagering of money or something of value on an event with an uncertain outcome with the primary intent of winning money or material goods. It is a negative manifestation of Filipino psyche, that is relying his future in terms of luck;

**“WHEREAS**, it is with high pride to note that for so many years, Bulalacao is the only municipality in the Province of Oriental Mindoro which is free from loteng or jueteng, all types of illegal number games and other forms of gambling activities;

**“WHEREAS**, lately, information had spread in the entire municipality that Peryahan ng Bayan being maintained and operated by Globaltech Mobile Online Corporation and other individuals coming from nearby municipalities. This gambling activity is considered to be an economic menace for it would result to financial drain of our remaining financial resources as people may tempt to rely on luck rather than on work without knowing that their little money saved were being siphoned by the greedy operators;

**“WHEREAS**, the Government in view of the moral and social malfeasance and misfeasance of the law which intends to protect its people against exploitation is urging those men in uniform to bring these violators into the folds of the law; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Express strong objection of the Local Government Unit of Bulalacao against the operation of Peryahan ng Bayan operated by Globaltech Mobile Online Corporation, all types of illegal number games and any other forms of gambling within the jurisdiction of Bulalacao, Oriental Mindoro;






